## 11. Presentation of the village and reports

#### i. Health and Safety:

- a. Report (assets around the village)
  - 1. Bus shelter tiles and internal board of roof damaged. Quote from Osier Developments received. The Clerk was asked to get further quotes.
- b. It was reported that the lock on the bin near The Croft was broken. It was agreed to get rid of this bin, particularly as it was sometime used for disposal of unbag dog poo. The Clerk was asked to approach NNDC to see if they could assist with the removal and disposal.

#### 12. Playground.

- i. **Public consultation**: questionnaire delivered with the Newsletter in June and also circulated to parents at Pre-School and Primary School.
  - 19 responses all in favour of new equipment
  - About 50% would maybe help with fundraising: donation, bake sale, coffee morning, yard sale, bingo, craft fair.
  - Interpretation of choices for Slide, Trim Trail, Tipi Carousel and Swings. (first choice weight 4, second choice 3, third 2, fourth 1): Swings 58 points; Trim Trail 56 points; Slide 47 points; Tipi carousel 29 points. Also requests for zip wire, pyramid climbing nets, ground level trampoline, items suitable for disabled children / wheel chair user, parallel bars, roundabout, fencing.
